Mandatory overtime is illegal (so is speeding but, until the little blue light goes on and you are marched before His Honor to explain your actions, you never really think it's going to be enforced). It's called "Selective Enforcement" and the practice has become so widespread in this country it's no wonder no one is paying attention to this newest law. Managements all over Massachusetts are ignoring the law as they continue to minimally staff hospitals and cover sick calls and schedule "holes" with mandated overtime. Nurses are continuing to complain and comply because that is what we do. After all, people continue to be sick and caring for them is what we do. Until they march someone out in handcuffs (or start imposing some hefty fines), it's unlikely management will pay attention to the law.

This is discouraging but not hopeless. Continue to report when you are mandated. Like other dangerous practices, mandated overtime must stop!

Unsafe staffing is another dangerous practice that must stop. MNA is actively working to bring the question of safe staffing to the public in the form of a ballot initiative. The Pledge Drive is underway and signature collection on the actual petition should be starting in September. It is imperative that we all participate in collecting these signatures. Unsafe staffing is already costing lives and health and the longer this takes, the higher the body count will get. This is very real and very deadly. We all know of instances where unsafe staffing has cost someone...costs in time away from family/work, costs in complications, costs in lives lost. Despite our best efforts, the body count is going up and we need to ramp up...please get your signatures in today.



#### Region 3 Member Convention Reimbursement Policy for 2013

As you may know, during our Annual Conventions our members often participate in job actions or social justice events during the convention days. We have learned over the last several years, as we have faced attacks on our working conditions and our ability to provide safe care to our patients, that we need our communities' support. This year, we felt it would be wonderful to contribute to a Regional community charity. This charitable work gives us an opportunity to show that we care for our communities, and for our patients. We have a stake in our patients' well being, no matter where they are.

Region 3 has been an avid supporter of Independence House in Hyannis, the *only comprehensive community-based resource on Cape Cod, providing free and confidential services for survivors of domestic and sexual abuse*. Primarily through semi-annual food drives, Region 3 has stocked the IH food pantry and provided large supplies of diapers, cleaning products, paper goods and personal products throughout the year.

**Independence House has other needs, and so, we are asking you to participate in a statewide collection** for Independence House and we intend to make a presentation to them on Thursday at Convention.

## Other Things You Should Know...

### **Researching Your Facility: A Quick Guide to Understanding More about Your Hospital**

This guide is an effort to provide you with the tools you need to quickly access more information about your hospital. Some of the questions nurses typically have are about a facility's finances, executive leadership, and staffing, and below are several resources that may be able to answer some of your questions.

#### **Finances**

Nonprofits in the U.S. are required to submit a *Form 990* (financial statement) to the IRS. The *Form 990* contains information on an organization's revenues and expenses, assets and liabilities, total employees, compensation, and so on. The *Form 990* often includes an Audited Financial Statement, which provides a narrative account of a hospital's financial situation and will offer more details, including Related Party Transactions, affiliated businesses, capital projects and expenditures (construction; medical equipment), charity care, and community support efforts.

#### **Foundation Center (<http://foundationcenter.org/findfunders/>)**

This website provides free access to the last five or six years of an organization's *Form 990s*.

#### **Center for Health Information and Analysis (CHIA)**

#### **(<http://www.mass.gov/chia/researcher/hcf-data-resources/financial-performance.html>)**

CHIA is a state agency that tracks information on the healthcare industry, releases reports on hospital financial performance, administers databases of hospital utilization and discharges, and maintains and reports on a number of other health-related issues. CHIA releases the quarterly Hospital Fact Sheet – a quick snapshot of a hospital's finances over the last several years, up to the end of the most recent fiscal quarter.

#### **Community Benefits**

#### **Attorney General ([http://www.cbsys.ag.state.ma.us/cbpublic/public/search\\_programs.aspx?section=1](http://www.cbsys.ag.state.ma.us/cbpublic/public/search_programs.aspx?section=1))**

In Massachusetts, nonprofit hospitals are required to assess the healthcare needs of their communities and work with community partners to develop programs. Hospitals provide the AG with a report that includes community characteristics, populations in need of healthcare, and details on each program the hospital offers.

#### **Leadership**

#### **Hospital Website & Press Releases**

The best and most accessible sources for information on executive leadership and Boards of Directors are hospital websites and press releases, which provide bios for new Board members and tout the activities and achievements of executives.

#### **Form 990**

For information about executive compensation, the best source is the *Form 990's Part VII or Schedule J: Compensation of Officers, Directors, Trustees, Highest Compensated Employees, and Independent Contractors*

#### **LinkedIn (<http://www.linkedin.com/>)**

Once you've identified who the key players in an organization are, you may want to find out more about them. LinkedIn offers information on the professional backgrounds of high-profile execs and Board members.

#### **Staffing**

#### **Patient Care Link (<http://www.patientcarelink.org/>)**

Patient Care Link (formerly Patients First) provides unit-by-unit staffing reports and plans. The information is reported by the hospitals, so the veracity of the information is hard to determine, but there is no better option.

## Around The Region

**Morton Hospital** — We are still in negotiations. The large four hospital group session has broken out into individual sessions for each hospital and then we are meeting again at the end of the month all together at the large table to go over common issues. There have been several reductions in force involving middle managers and nursing educators, so we have been dealing with bumping and position availability. The pedi unit remains open at times and closed at others; it's still unclear what the plan is. The latest from the pedi staff is that they will be placed in the new ER pedi observation unit when that is complete.

**Brockton Hospital** — Union negotiations have stalled after a year and a half. The stumbling blocks are health insurance and pension. There is no compromise to lose benefits. We have not made progress even with the federal mediator. At some point we will probably have the membership vote. It's your contract, your benefits, your vote.

MNA is in full swing collecting signatures from nurses, family, and friends for the safe staffing ballot bill for the 2014 November elections. We need 70,000 signatures by November. This bill is similar to the California model whereby a nurse can be assigned only a specific amount of patients per nursing specialty and acuity; the nurse/ patient ratio. The postcards, green sheets and signature sheets are being distributed to nurses. Please have them filled out and return to the bargaining committee or me. This is your ballot bill. The public will vote for it. Most people know a nurse or have one in their family. They know our stories; It will pass. Let's do our part and get the signatures for the state.
